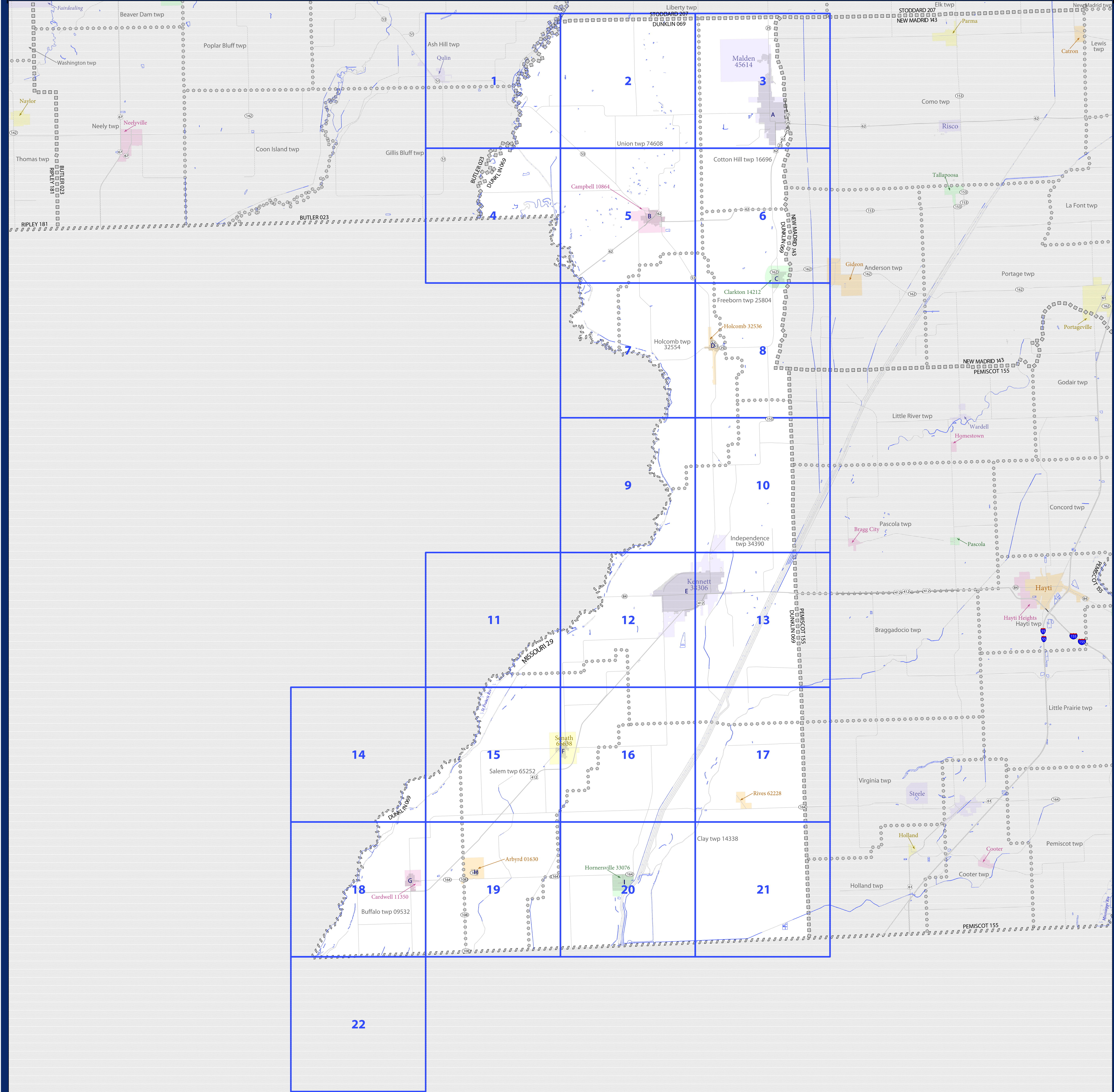

Location of County within State

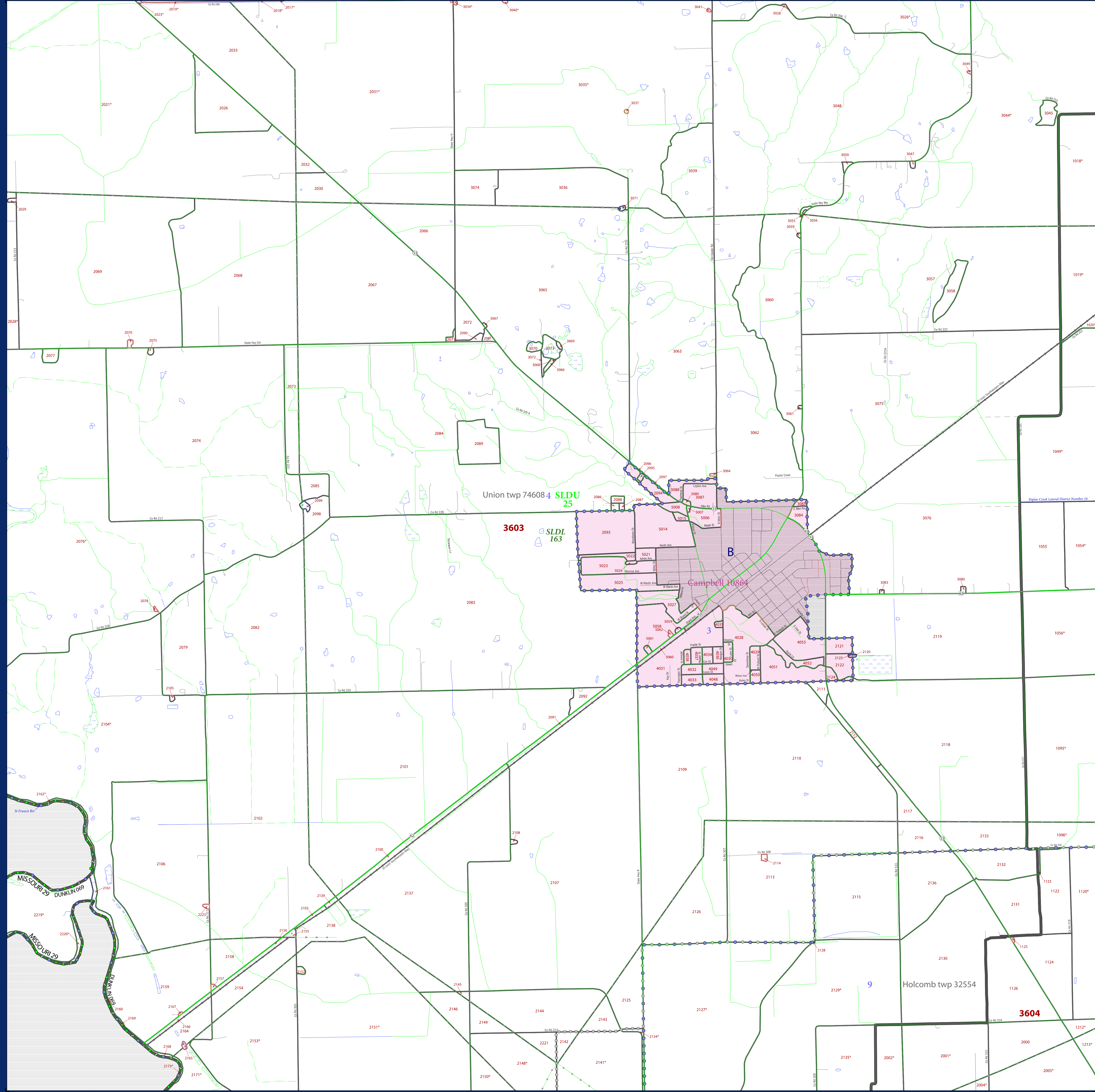

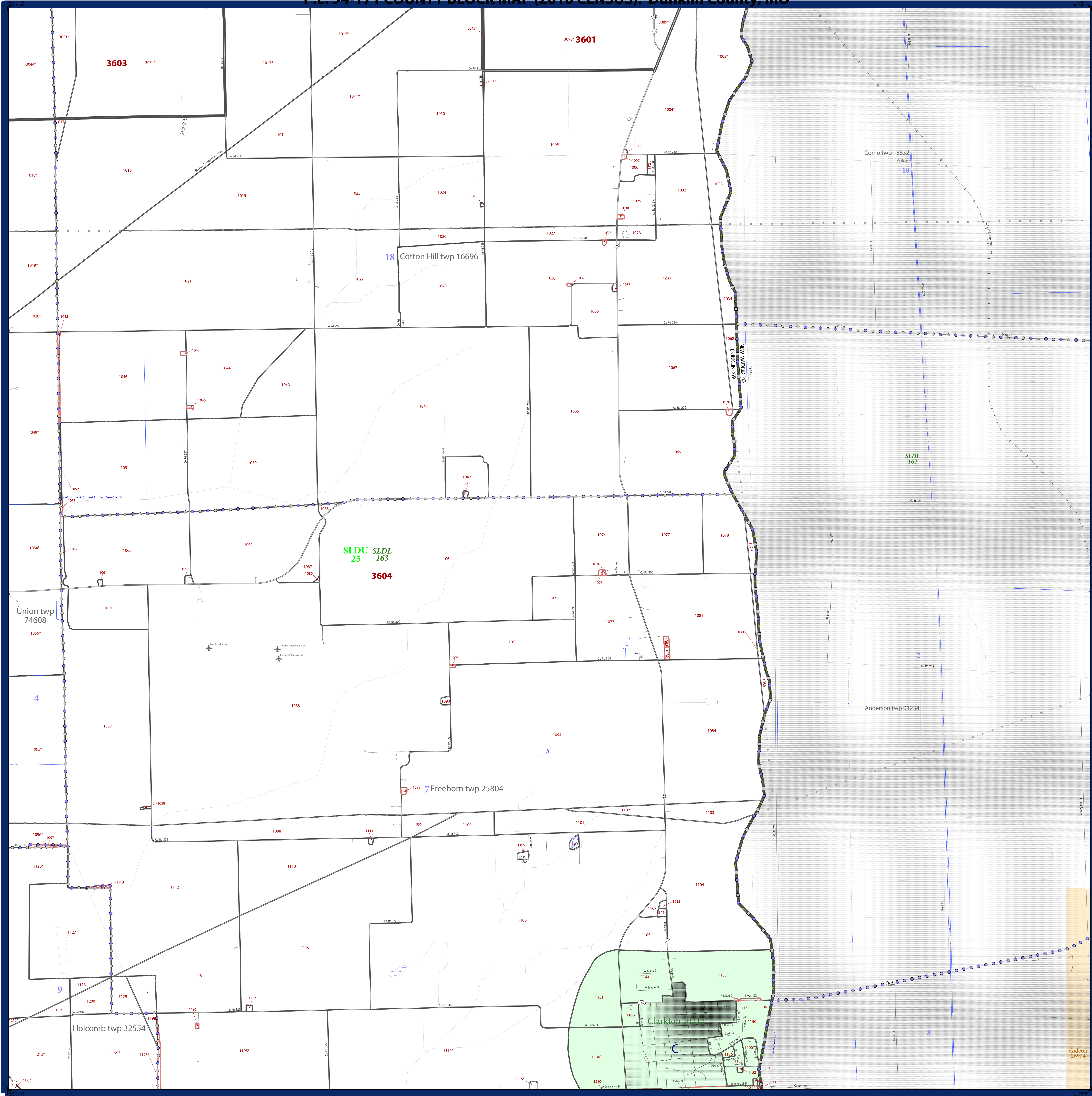

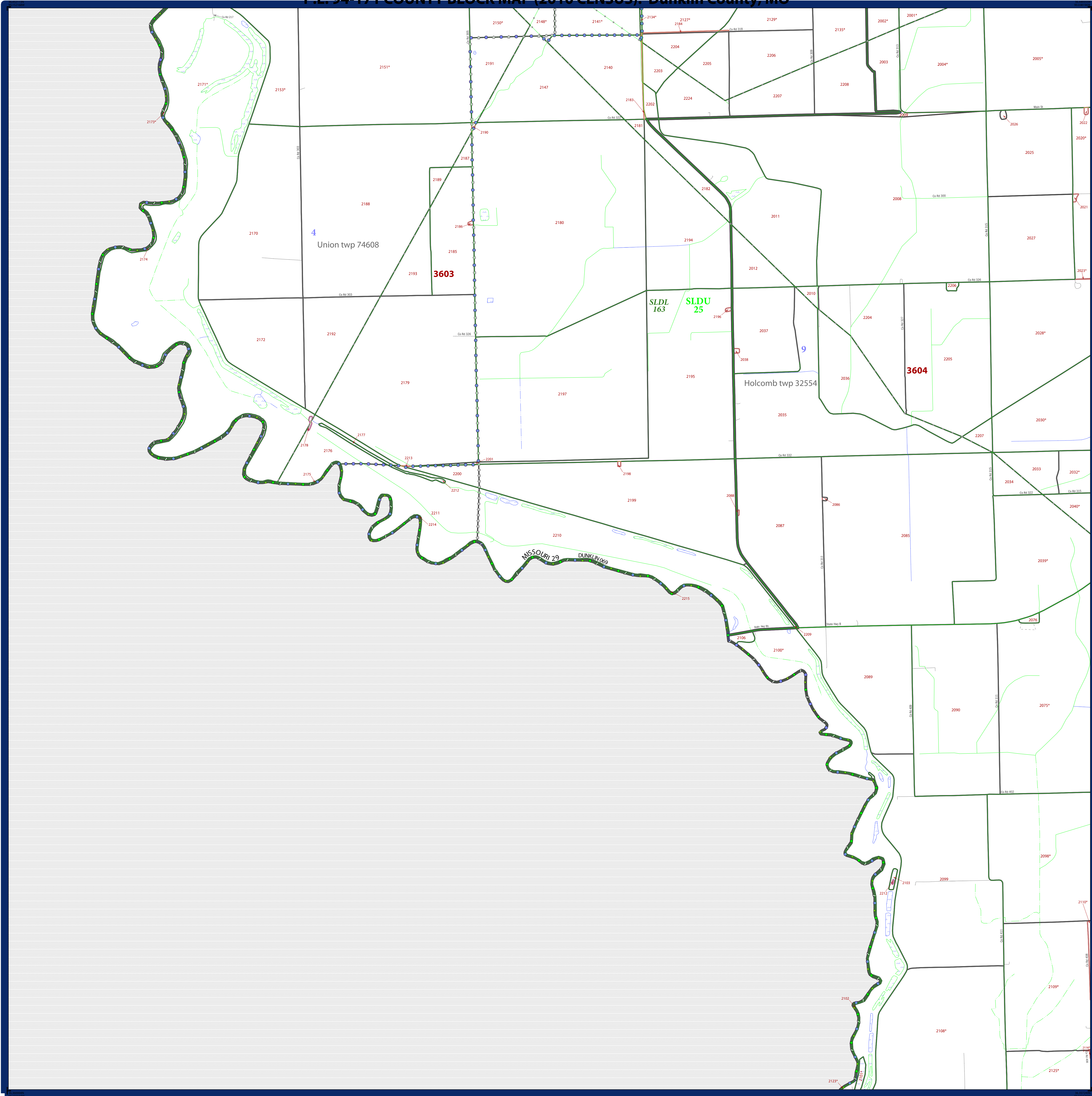

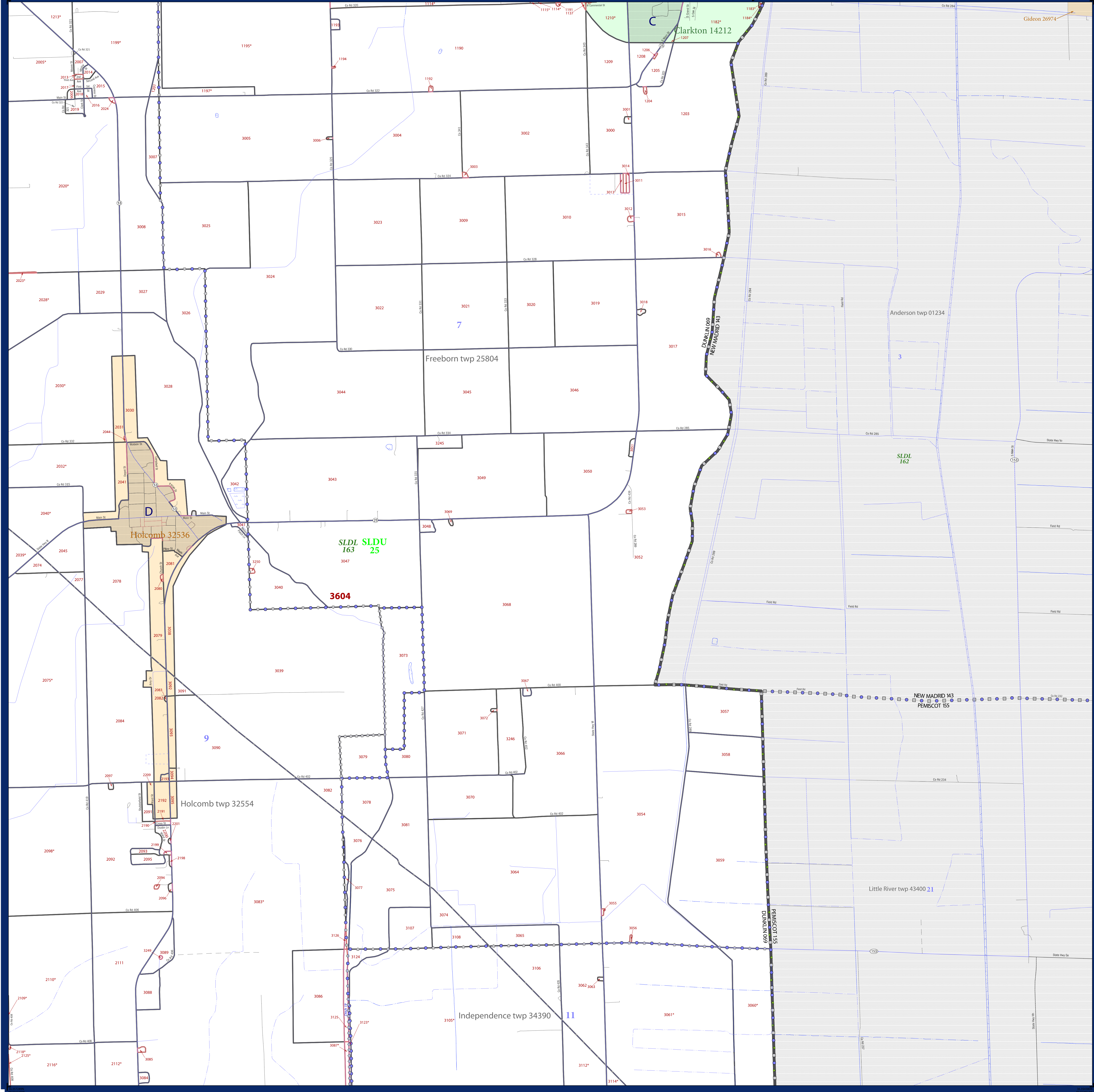

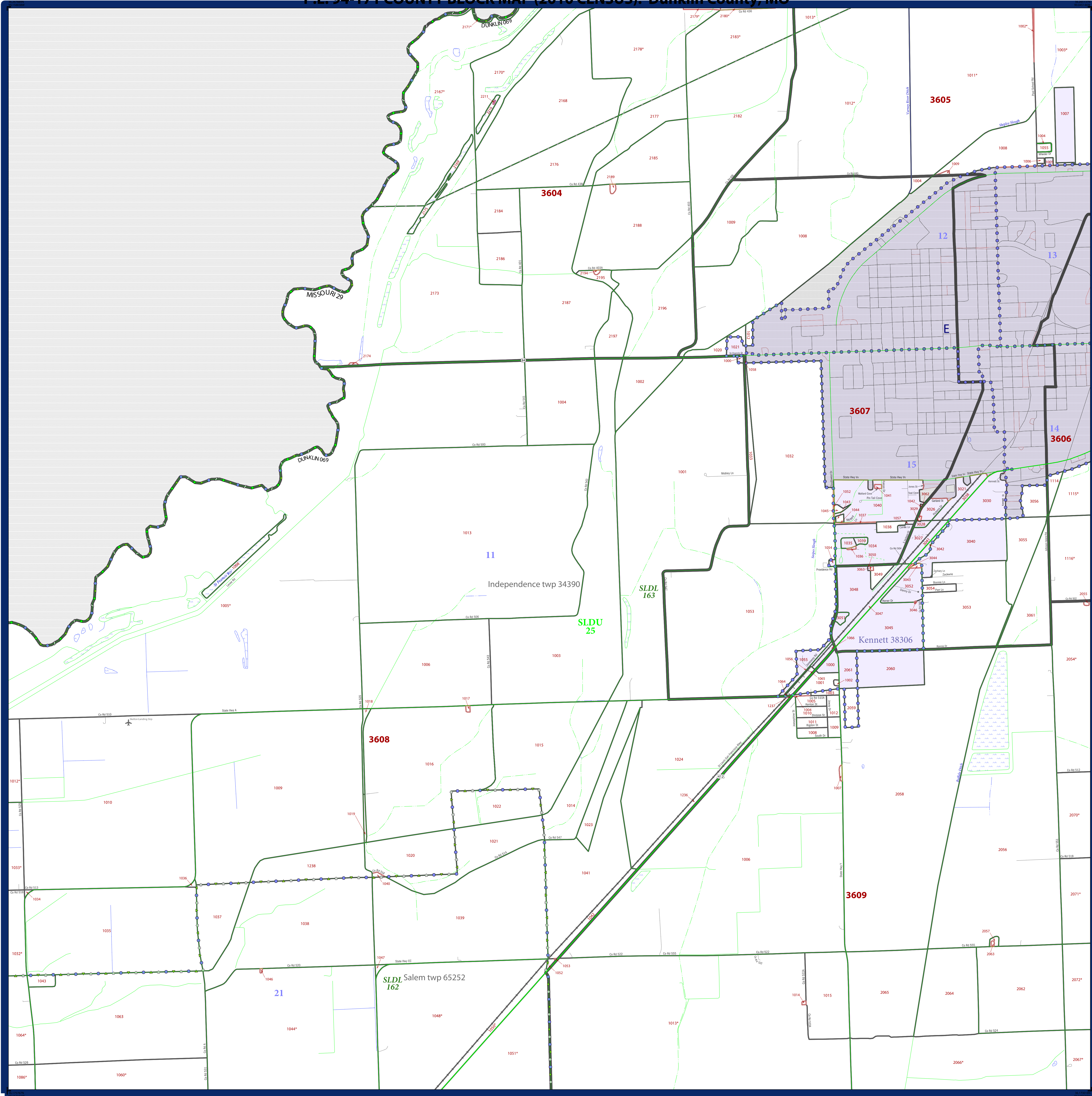

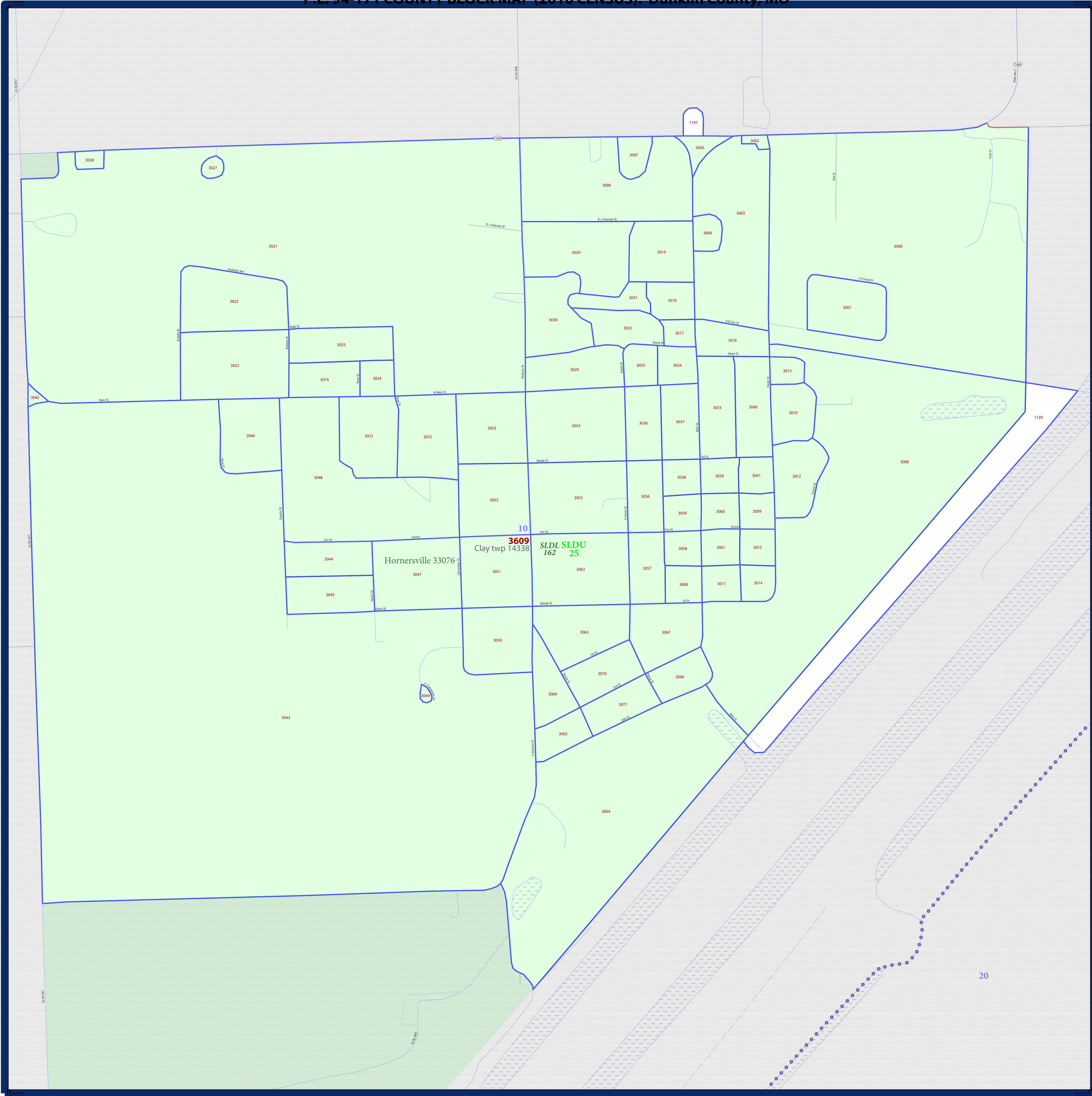
