Location of County within State

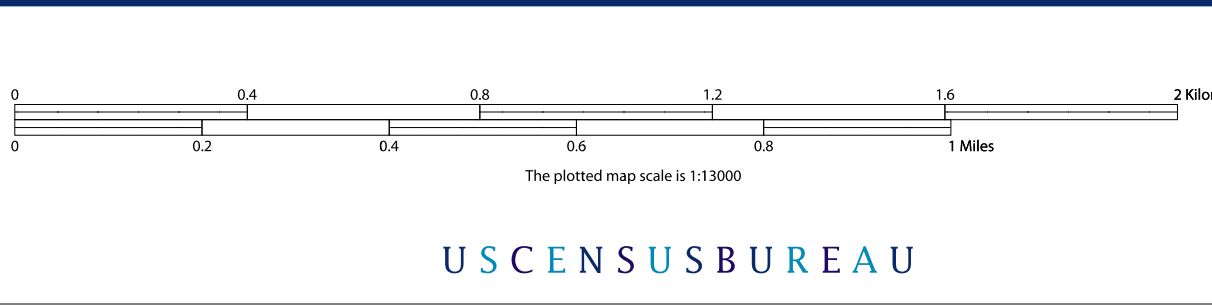

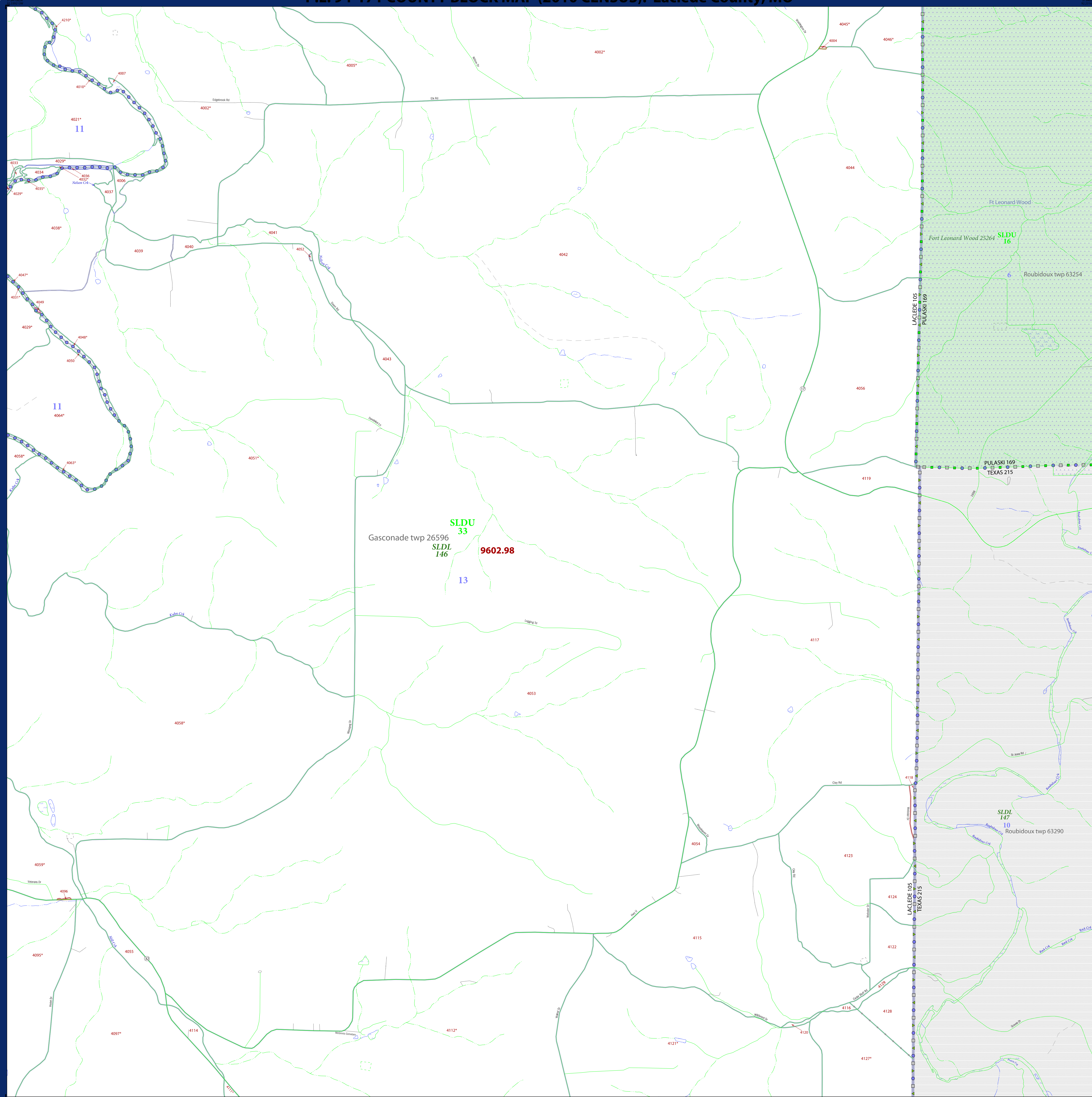
Location of County within State

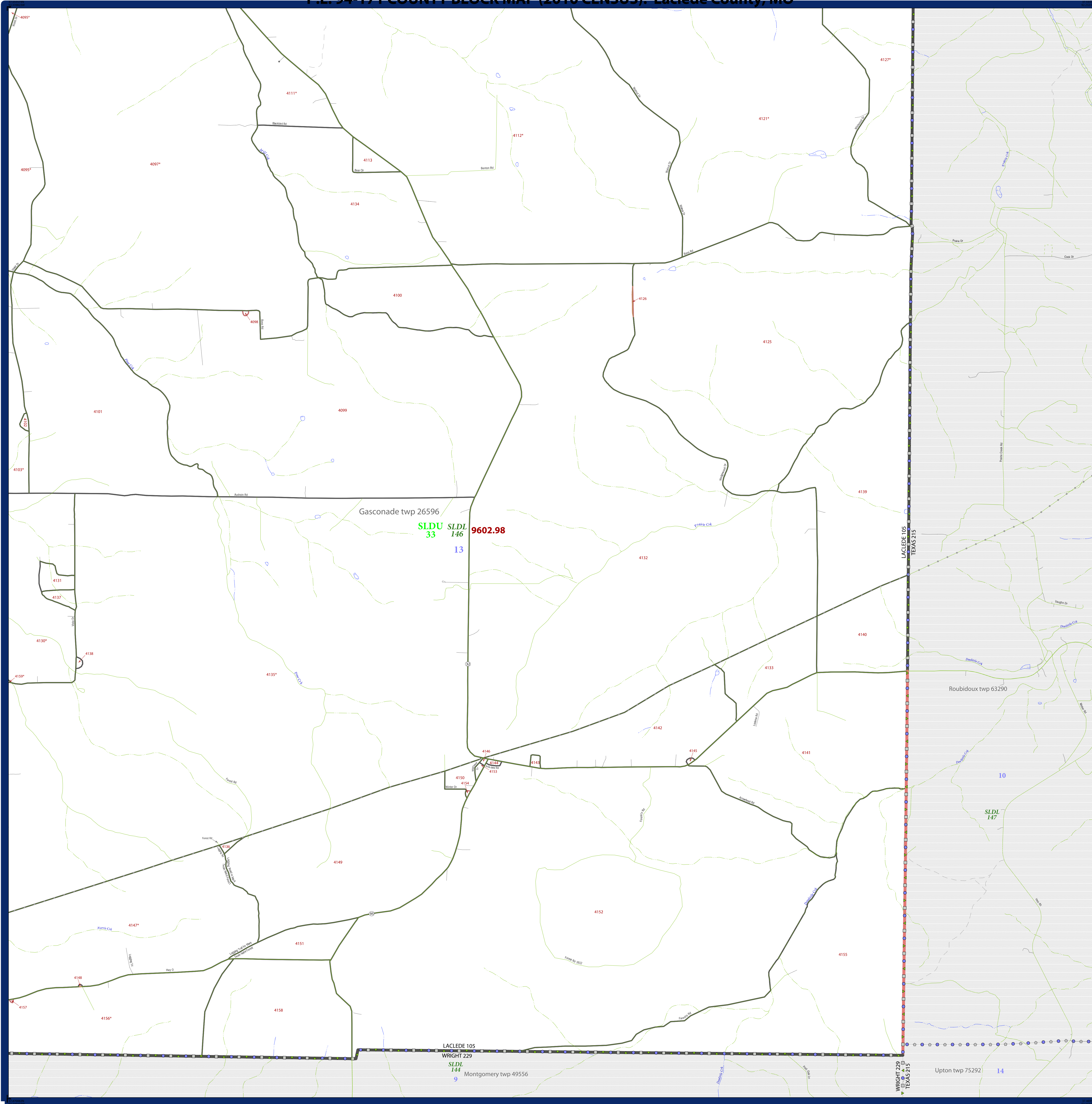
