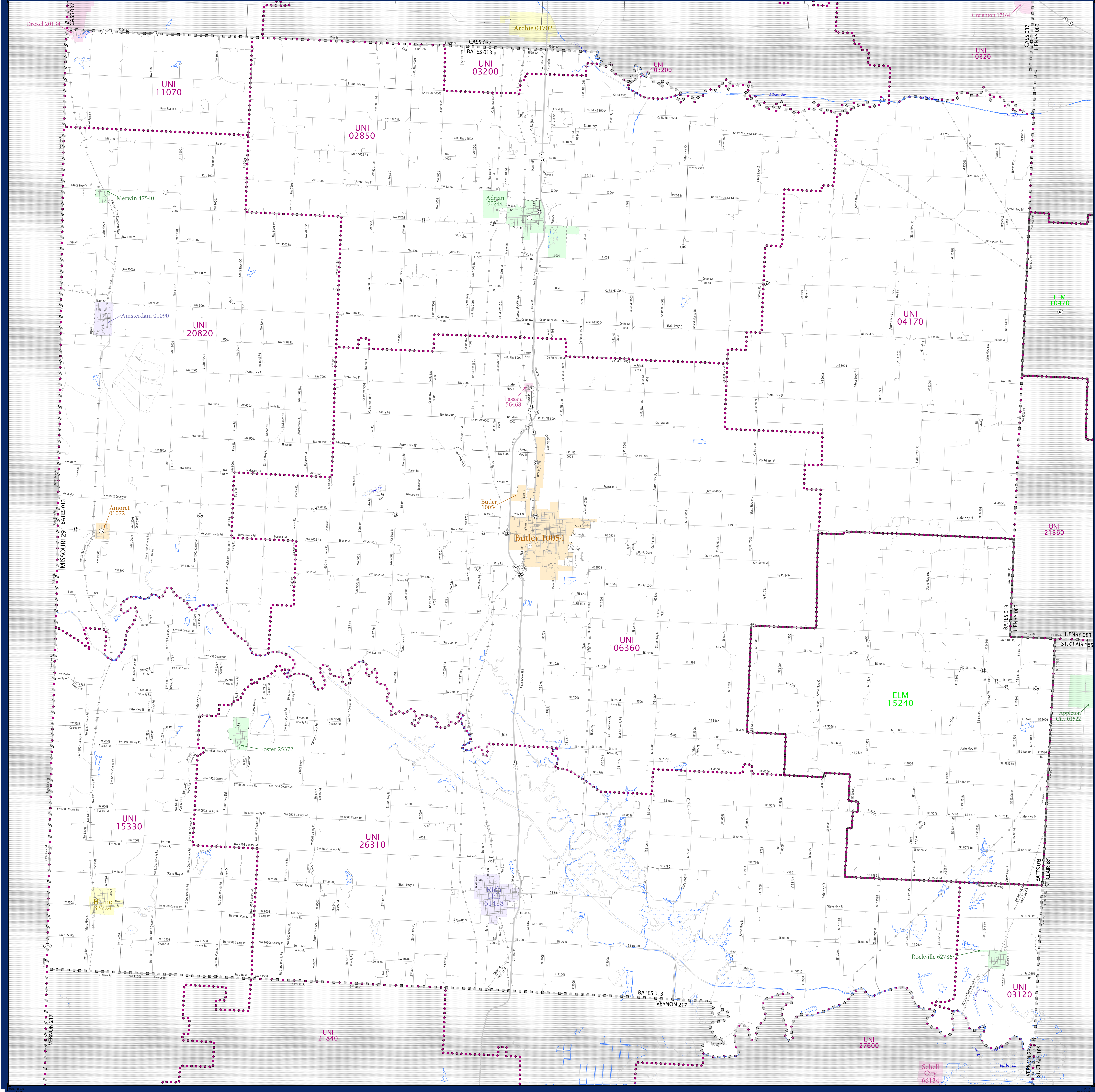


SCHOOL DISTRICT REFERENCE MAP (2010 CENSUS): Bates County, MO
