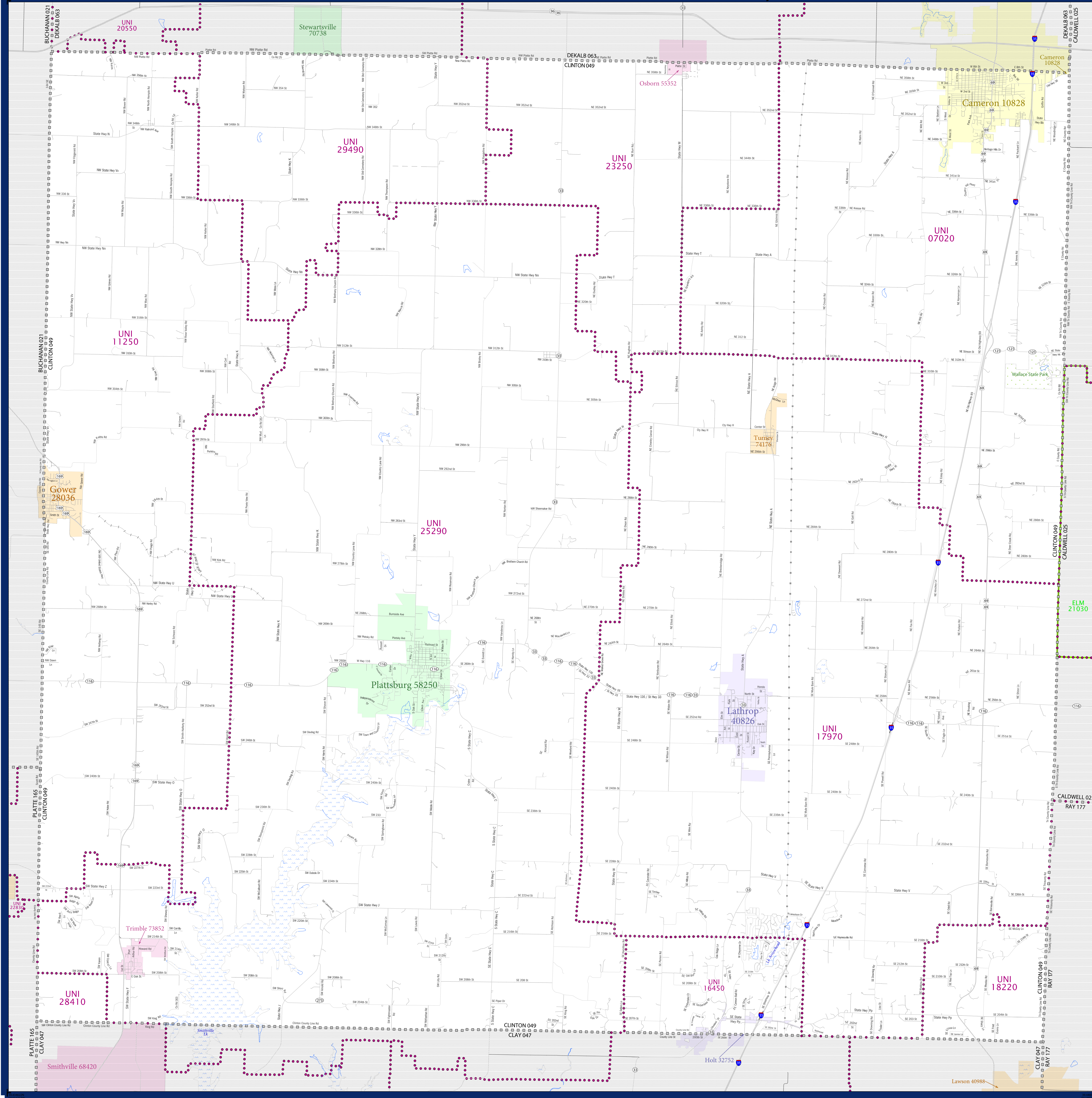


SCHOOL DISTRICT REFERENCE MAP (2010 CENSUS): Clinton County, MO

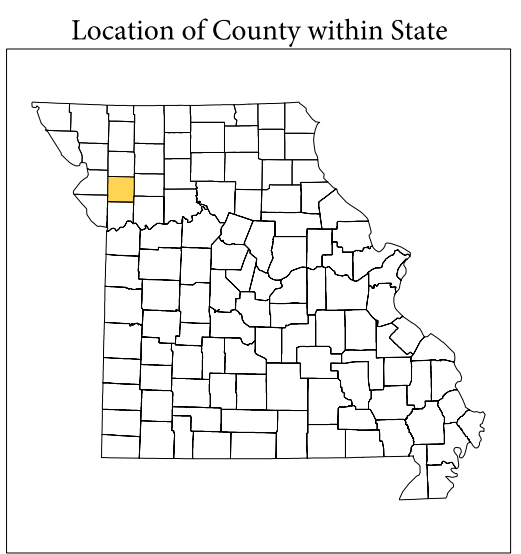
Where state, county, and/or MCD boundaries coincide, the map shows the boundary symbol for only the highest-ranking of these boundaries.

3 Place label color correlates to the place fill color.

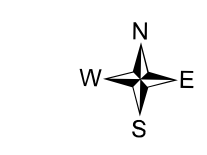
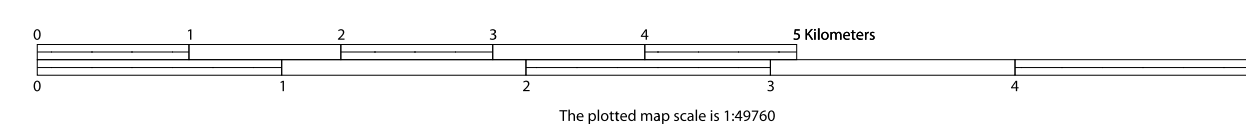
