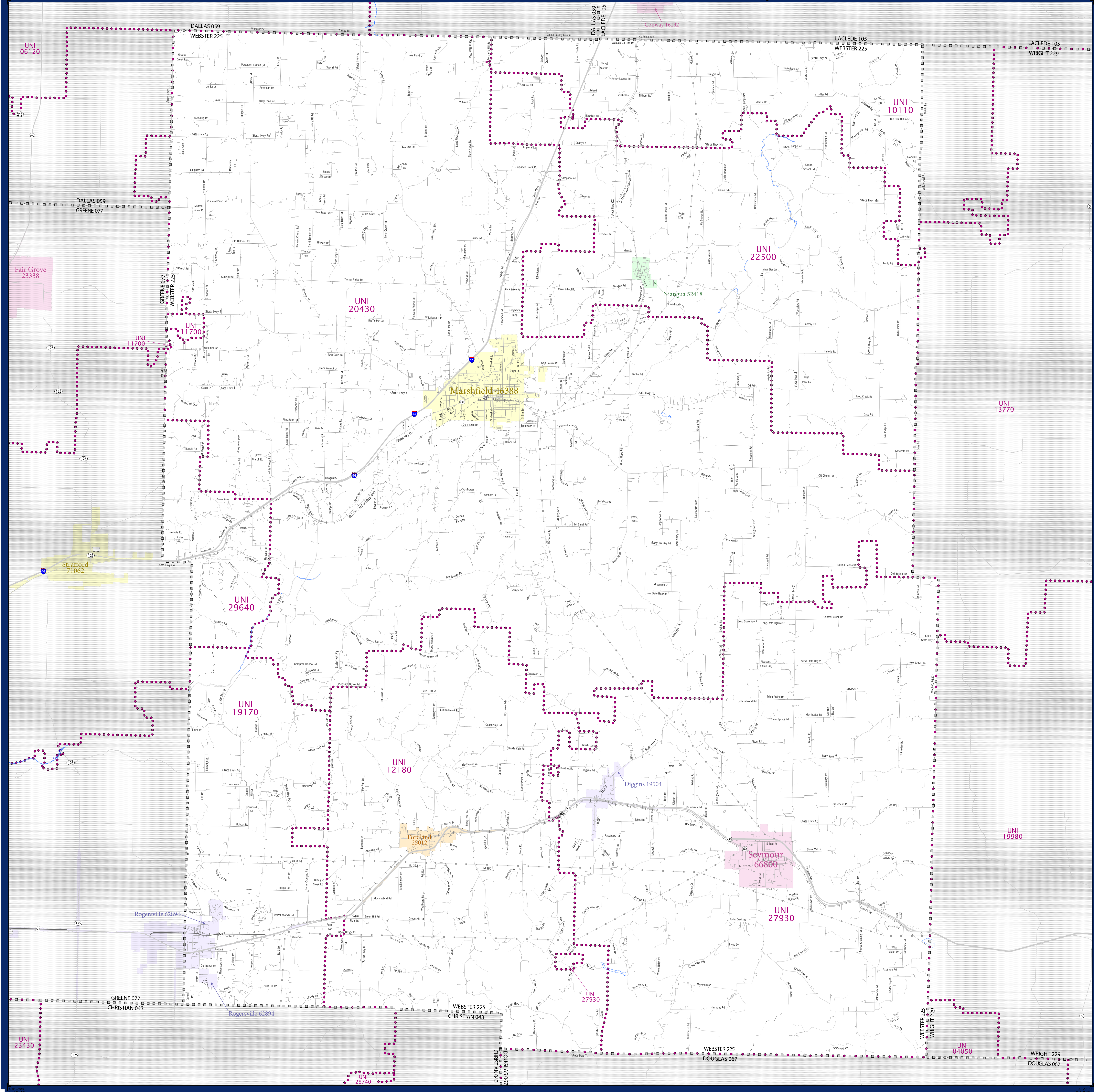


SCHOOL DISTRICT REFERENCE MAP (2010 CENSUS): Webster County, MO

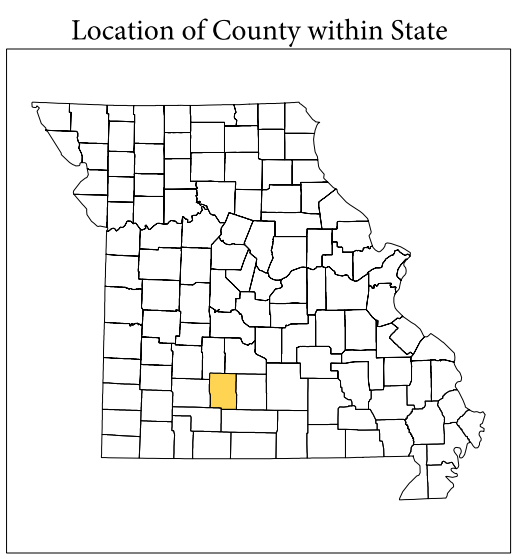
