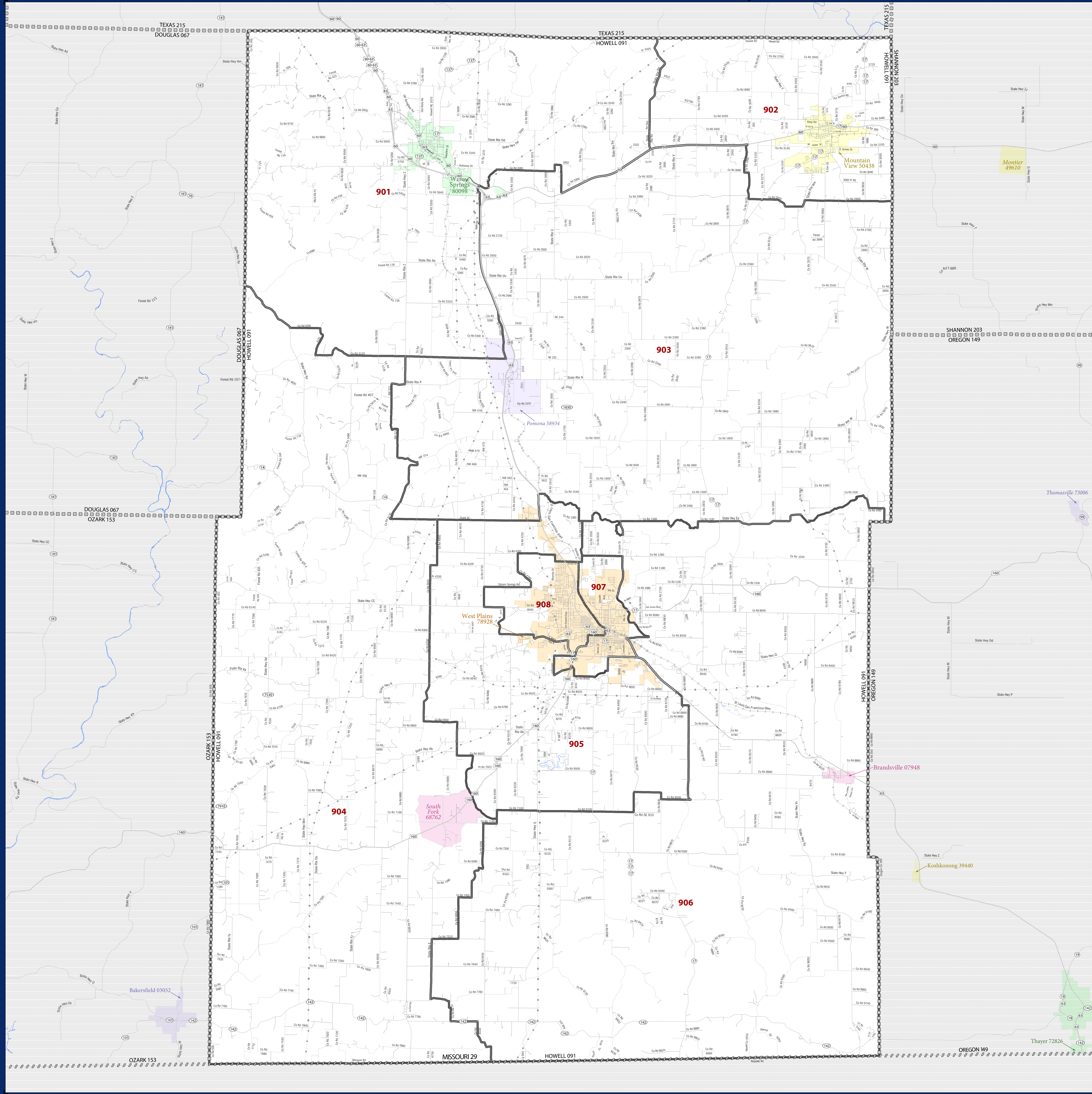


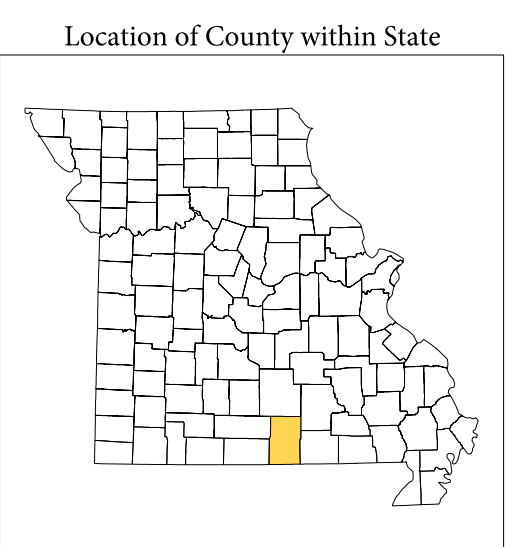

- 3 Place label colors correspond to the place GSI colors.

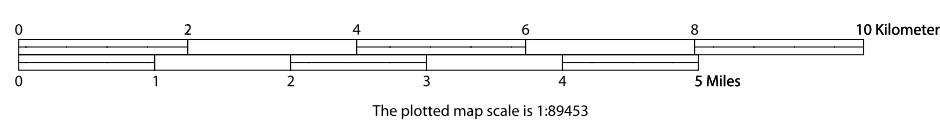
