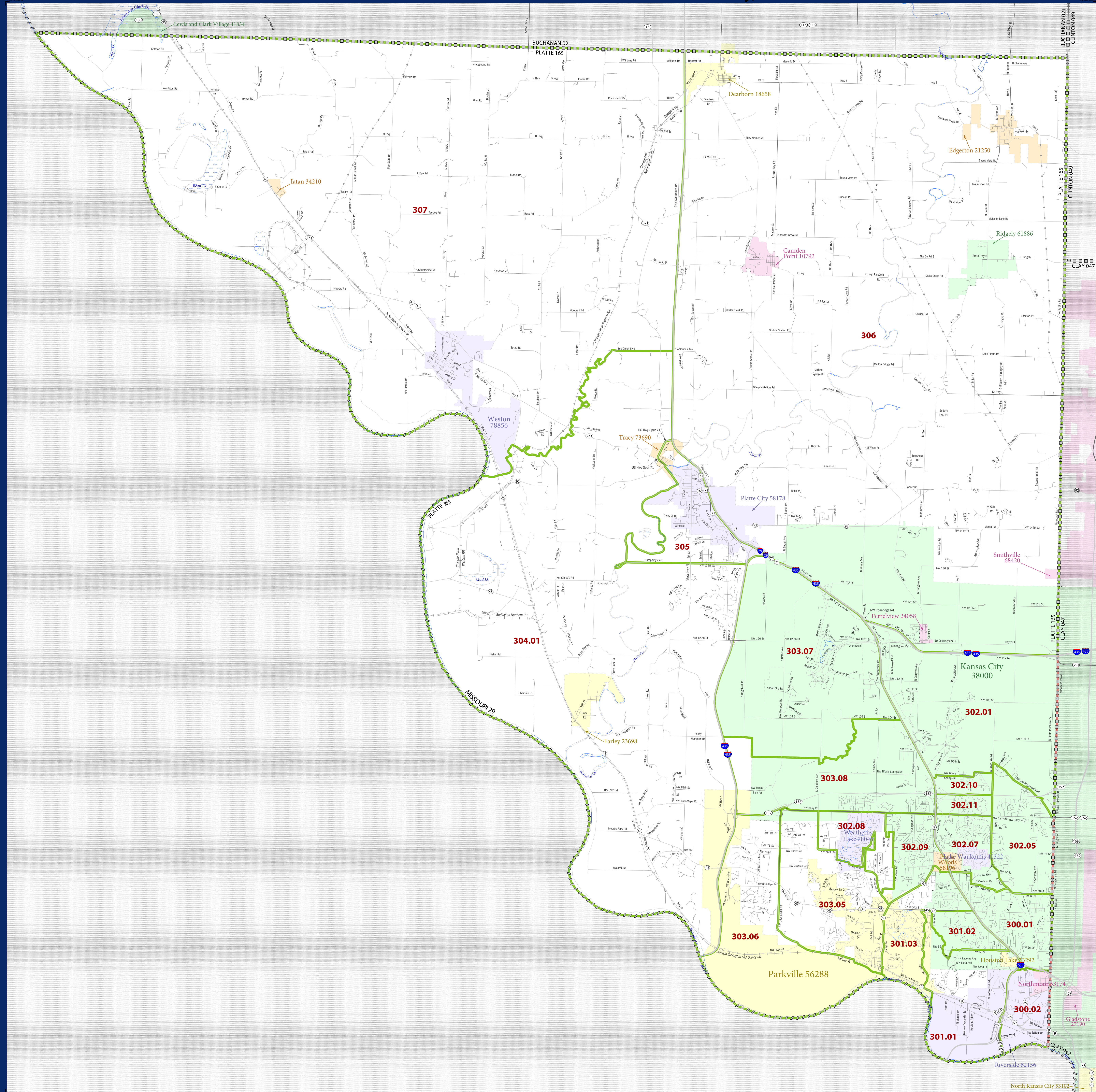

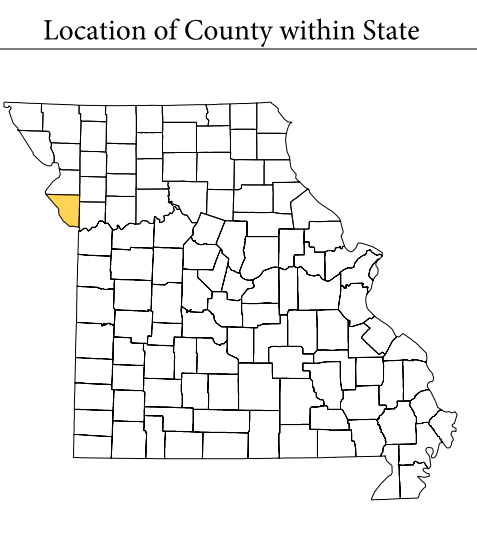

- 3 Place label color correlates to the place fill color.

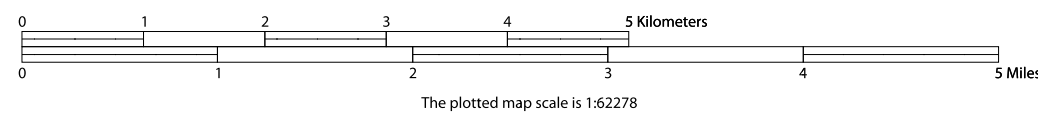
